AFFIDAVIT

Before me, the undersigned authority, on this day personally appeared HELEN PARAMORE, Child Protective Services Specialist, affiant, who having been by me first duly sworn upon oath stated to be over 21 years old and to have personal knowledge of the facts stated here in:

I employed by the Texas Department of Human Services, as a social worker. On 12/12/86, I received a referral concerning a child, named BEVERLY P. TROUPE. On 12/11/86, BEVERLY P. TROUPE was admitted to Darnall Army Community Hospital, allegation were that the child was admitted to the hospital alleging sexual abuse. Dr. SAMUEL MUJICA was the admitting physician. The child was then interviewed by this worker, HELEN PARAMORE on Saturday, December 13, 1986 at approximately 5:15 p.m., at that time I explained the reason for having to talk to the child. The child was thoroughly questioned during which the first part of the interview the child adamantly denied that any one had hurt her. The child kept stating that she doesn't remember and that it just start hurting when I went to the bathroom. The child did related several stories to this worker concerning how she may have been hurt in the vaginal area. When the child finally admitted that an adult had been hurting her in the vaginal area, this worker asked the child who that person was, the child would not state and stated that she was afraid too. The child kept on stating I can't tell you because it would get them in trouble. The child is extremely frighten about naming the person. At that time, the child stated that her mom had told her that she doesn't remember who did that to her. When worker questioned child about events that she related of this adult to having done to her which involved penetration of the anus, digital penetration of the anus, digital penetration of the vagina and also penile penetration of the vagina. The child finally did admit to this worker whom the perpetrator was. The child stated that it was my dad. When questioned the child how long the abuse have been occurring the child said it started in first grade when I was in Germany. When questioned if the child had ever spoken to her mother about what her father, BRIAN K. TROUPE have been doing to her, the child stated yes I told her in Germany and my mom said he did and asked her what, and when the child related to the mother what the father had done the mother confronted the father and a big

argument took place. At that time, the mother, the child stated that she remembers the mother saying you will have to stop doing that because she just a little girl. Worker asked child if the sexual abuse had ceased at that time, the child stated no, that he was still doing it. The child also related that she had told a babysitter in Germany, named Janet who lived across the street that her daddy was hurting her down there indictating her vagina area. The child stated that Janet had told her mom about what she had told her and that the mother once again confronted the father and an argument took place. The child stated at that time that she thought her parents were going to live in different houses perhaps indictating divorce. When questioning the child as to the last time that she had told her mother, that it was her father hurting her down there the child stated on Friday, and worker then questioned child as to what she had told the mother. The child stated that the mother had asked her who had hurt her down there. The child said that she had told the mother "my dad did" and when the worker questioned as to the mother response to her answer the child simply stated that she said "nothing". That Friday would have been December 12, 1986. When questioning the child if any sexual abuse have occurred to any of the other children in the home, the child stated that CONSTANCES the one year old, sister cries a lot when dad changes her diaper. When questioning the child as to why the baby, CONSTANCES' cries when daddy changes her diaper, BEVERLY stated that she cries because she is scared. When questioned, what CONSTANCE was scared of BEVERLY stated that she scared he will put his finger inside and it hurt her. When BEVERLY was questioned again if any sexual abuse had taken place between the father and the other two boys residing in the home, BEVERLY stated no. The child, also talked about the father having played with himself in front of her, the child stated he had done this in her room. When questioned if anything had come out of his penis the child stated no. When questioned if the father had ever put his "ding dong" term used by child inside of her that child stated yes but I tell him to stop because that really hurt. When questioning the child how far the penis went in the child stated about half way. At this point all reasonable efforts have been made by the Department of Human Services to prevent or eliminate the need for the removal of the child. But it is not the child's welfare to remain at home. Allegation that were made of the father, sexually abusing the one year old child, CONSTANCES have no medical evidence to substantiate the abuse. This worker feels that both female children need to be remove from the home in order to ensure safety and protection.
